

IMPORTANT VACCINE PRESCRIBING INFORMATION CORRECTION
 Fluzone[®], Influenza Virus Vaccine, Single-Dose Vials NDC 49281-011-10

November 14, 2011

Dear Health-care Professional:

We are sending this letter to notify you of an error in the Prescribing Information (PI) that was included in packages of 10 single-dose vials of Fluzone vaccine (National Drug Code [NDC] 49281-011-10).

The third column header (labeled “Fluzone 0.5 mL Dose”) and fourth column header (labeled “Fluzone High-Dose 0.5 mL Dose”) in “Table 8: Fluzone, Fluzone High-Dose, and Fluzone Intradermal Ingredients” were inadvertently transposed, resulting in reversing the listings of ingredients and quantities per 0.5mL dose for Fluzone and Fluzone High-Dose vaccines. The correct version of Table 8 appears below and the full PI is available at www.VaccineShoppe.com. Please note that Fluzone vaccine contains 0.05% gelatin.
